Peter Van Bemmel, gave the financial report in Maaike Van Bemmel's (Treasurer) absence.

New Business:

Minimum Lot Size: Kathy Welsh and Peter Van Bemmel are working together to establish minimum lot size standards for those properties not yet covered by these regulations, specifically in the 800 block of Kipling and the 600 block of Harold

<u>Esplanade:</u> There was a request to establish an Esplanade Committee. A motion was seconded and passed calling for Patty Thompson to chair this committee.

<u>APA Newsletter</u>: There has been interest in including neighborhood deaths and births in the newsletter. The possibility was discussed at the meeting, and it was determined to leave this to the editor's discretion on a case by case basis.

<u>Website</u>: Peter Van Bemmel requested money from the Treasury to purchase additional storage space on the web server (estimated at \$5/month). This additional storage will allow all the APA minutes to be available on the website. This expenditure was approved by those in attendance.

Other Business:

The property owner of 803 Kipling claims that he plans to renovate his burned-out house. The running water problem in the 800 block of Marshall has been reported (repeatedly) to the City.

803 Kipling

This building is on the agenda on the 25th at the Building Standards Commission. They can decide on (1) tearing it down (immediately if it is an imminent danger, after 90 days otherwise) or (2) securing it (a lien will be placed on the property for the cost of securing it).

We can put in our request at the Building Standards Commission hearing. They may honor this request at their discretion.

We need to formulate our request tonight.

Of the ones living in the immediately vicinity of 803 Kipling:

The building is dangerous and attracts kids and undesirable individuals.

The least that can be done is to have the building secured. It needs to be boarded up and perhaps a chain link fence put up around it. It should also be posted.

Is it worth trying to save the building?

The house was built in 1916 and is contributing as a Historic Building. It is a Craftsman.

What happens if it is torn down?

It is unrestricted, so umpteen townhomes could be built on the spot.

The official assessment by the planning commission (Pete Stockton) is that it is salvageable. The fire department has not declared it an "imminent danger" after the fire. However three architects in our neighborhood recommend that it be demolished. Builders who have looked at restoring it (contact Jason Norwood, Peter van Bemmel) say it is not

cost effective at the asking price of \$425,000. It is hard to get concrete answers, but Denise and I believe that it is at least \$100,000 overpriced, even for the lot alone. For a quick, back of the envelope calculation for building a single family residence:

cost of building a quality 3000 sqft house 300K cost of the lot 425K total cost 725K

homes here are selling in the 600-800K range

Unless the seller comes way down there is no profit in this. HCAD land value 220K. This may take a long time...

Reasons for demolition

- The building is a danger to children and attracts vagabonds.
- It is a nuisance and an eyesore.
- We don't want to wait for years until it is sold.
- Builders may want to develop townhomes.

Voting proposition

- A) We want this house preserved for now; we want it secured; we will revisit this decision in February 2010
- B) We want it demolished (but town homes may be built)

The vote was taken by counting hands. Of the 14 present 13 voted for A, 1 for B.

I will present this result to the Building Commission on the 25th of June.


New Business:

Existing current Chairs for the Historic Committee, the Esplanade Committee, the PIP Committee, and the Deed Restrictions committee were named to serve again for the coming year..


