- 1. Improve drainage on SW corner of intersection between Stanford and Harold
- 2. Repair pavement on Audubon Place, North bound
- 3. Improve rain water runoff in the following places:
  - Harold 600 block South side Kipling – 600 block North side Marshall @ Stanford SE corner
  - Marshall 800 block North side

The pavement is graded incorrectly. There are pools in front of several houses after a rain, which remain until they evaporate. Should be re-graded to flow to the gutter to minimize mosquitoes etc.

- 4. Grade the ally between Audubon Place and Garott
- 5. Improve water pressure in 600/700 block Harold North face (Requested 2008)

APA residents are encouraged to use the city's "311" service to report unlawful use of the abandoned building (by vagrants, criminals, etc) to encourage the city to take action.

#### Esplanade Committee

It was reported that a successful cleanup work party was recently undertaken. A proposal for consideration was made to see if interested parties would be willing to donate plants for installation. It was agreed that a call for donations would be made.

#### Westheimer Street Festival

Dan Piette reported that the planning group for a future Westheimer Street Festival held a recent meeting he attended. He reported less-than enthusiastic interest shown for the festival at the meeting and he reported at that meeting that few of our residents would be in favor of such a festival. The organizers are pushing ahead for now. The next planning meeting will be April  $26^{\text{th}}$ .

#### Buildings at Risk

#### Westheimer Street Festival

A general discussion regarding the potential Street Festival concluded with all in attendance expressing desire for the Association to resist any organizing efforts.

## Crime update

A general discussion of recent events in the neighborhood included comments about plant thefts and a continued increase in foot traffic.

A general discussion followed regarding the location of "historic district" signage in the area and possibility of neighbors along Audubon asking the city to take responsibility for the alley behind their properties on the east side.
